Agenda Item A: Approve Proposed FY 2008/09 Preliminary Budget -

Helen Fried, County Librarian (OCPL) and Steve Siemion, Director of Fiscal & Purchasing Services (OCPL)

Steve Siemion presented a detailed review of the handouts entitled "OCPL Proposed FY 2008/09 Budget – Revised 5-9-08" and "OC Public Libraries FY 08/09 Allocation Plan – As of 8-9-07." OCPL received the May Revise to the Governor's Budget yesterday, which does not include cuts to Library funding beyond the 10% cuts already reflected in this proposed budget.

Staff Directive: Kathryn McCullough (Lake Forest) requested staff send out an updated OCPL/Facilities Construction & Maintenance Branch Projects report.

A Motion was made by Guy Carrozzo (Fountain Valley) to pass the FY 2008/09 budget as presented and was seconded by Kathryn McCullough (Lake Forest). Hearing no objections, motion passes unanimously.

A Motion was made by Kathryn McCullough (Lake Forest) to reopen discussions of the allocation formula. It was seconded by Tom Beamish (La Habra). Hearing no objections motion passes.

The LAB discussed the strict application of the allocation formula and how it would impact Fountain Valley's branch hours in the next fiscal year.

A Motion was made by Kathryn McCullough (Lake Forest) to temporarily suspend the implementation of the allocation formula until a consultant can be hired to study the formula.
